### Protection Against Particulates



**DUST:** When a solid material is broken down into tiny fragments, dust is formed making this respirable and harmful to health.



**MISTS:** Tiny droplets form through the atomization and the condensation of liquid materials, such as spray painting.



**FUMES:** When solid materials are vaporized by the high heat and the vapor cools quickly, this condenses into very fine particles creating fumes.

### Protection Against Gases & Vapors

Gases and vapors are molecules so small they penetrate particulate filters. For these respiratory hazards a chemical cartridge is required.



Gas and vapor respirators have activated carbon cartridges which adsorb or absorb the harmful substances. These are distinguished by identifying letters and colors.
